Promotion	Cadbury Monopoly Promotion 2026
Promoter	Mondelēz New Zealand, 476 Rosebank Road, Avondale, Auckland New Zealand.
Eligible Entrants:	You can only enter this Promotion if you are: a) a New Zealand resident; and b) aged 18 years or older.
WHEN AND WHERE WILL THE PROMOTION RUN?	
Promotion Period	The Promotion starts at 12:00am NZ Standard Time on Monday 31 st August 2026 and ends at 11:59pm NZ Standard Time on Sunday 27 th December 2026 (Promotion Period). No entries will be accepted outside of the Promotion Period.
Where will the Promotion Run?	This Promotion will run in participating stores in New Zealand that stock and sell the Participating Products (Participating Stores).
ENTRY DETAILS	
Participating Products	Any Cadbury confectionery product (excluding products made by third parties under licence from the Promoter , for example ice creams).
How to Enter	To enter this Promotion, an Eligible Entrant must, during the Promotion Period: (a) buy any one (1) or more Participating Product/s from a Participating Store (Qualifying Purchase); and (b) visit nz.cadburymonopoly.com (Website), follow the prompts to the Promotion entry page; and fully complete and submit the online entry form with their personal details (first name, last name, email address, phone number) and upload their original itemised receipt/s for the Qualifying Purchase. Major Prize Draw Each valid entry submitted in accordance with the above will count as one (1) entry into one (1) of three (3) Major Prize draws. There are three (3) Major Prizes to be won. Entrants will, at time of entry, choose which one (1) of the three (3) Major Prize draws they enter. Daily Prize Draw Each valid entry submitted in accordance with the above will also give the entrant one (1) chance to roll the dice for entry into that day's Daily Prize draw. Entrants will roll two (2) dice to determine the number of entries they receive into that day's Daily Prize draw.



	There are three (3) possible outcomes of the dice roll. The two dice will land on a combined total of two (2), three (3) or five (5). Entrants will therefore get either two (2), three (3) or five (5) entries into that day's Daily Prize draw. There will be a Daily Prize draw to enter every day of the Promotion Period. Proof of Purchase Requirements	Entrants must retain their original itemised receipt/s for the Qualifying Purchase to verify each entry (Proof of Purchase).
What are the Entry Limits?	Multiple entries into this Promotion permitted subject to the following: limit one (1) entry per person per day. Limit one (1) entry per Qualifying Purchase. <u>Important note: each Proof of Purchase (original itemised receipt) is valid for 1 entry into this Promotion, regardless of the number of Participating Products purchased in the transaction.</u> The use of any automated entry software or any other mechanical or electronic means that allows an entrant to automatically enter repeatedly is prohibited and will render all entries submitted by that entrant invalid.
WINNER DETERMINATION DETAILS	
Winner Determination	There will be up to 360 winners. Up to 357 Daily Prize winners and 3 Major Prize winners. Winners will be randomly drawn for each draw from all valid entries in that draw. Except as set out below, Daily Prize winners for any given day in the Promotion Period will be drawn on the following business day. For example, the draws for valid entries received on a Friday, Saturday and Sunday will be on the next Monday (unless that Monday is not a business day). If a draw date falls on a public holiday, the draw will take place on the next business day. Notification of Winners	Major Prize Winners The Major Prize winners be notified by phone or in writing within 2 business days of the Major Prize draw, using the details provided at the time of entry into the promotion. The winners will be the registered owner of the phone number or email address provided at the time of entry.

	Daily Prize Winners Daily Prize winners will be notified by phone or in writing within 2 business days of the relevant Daily Prize draw, using the details provided at the time of entry into the promotion. The winners will be the registered owner of the phone number or email address provided at the time of entry.
VERIFICATION & DELIVERY	
Verification Requirements	Entrants and winners may be required to: a) provide proof of identity, proof of age and proof of residency to verify their entry (Proof of Identity). Identification considered suitable for verification is at the Promoter's discretion; and b) if requested, send their Proof of Purchase (for <u>all</u> entries they submitted during the Promotion Period) to the Promoter to verify that the relevant Prize should be awarded. If an entrant/winner fails to provide Proof of Identity and/or Proof of Purchase by the time and date stipulated by the Promoter, their entry/prize claim will be deemed invalid at the Promoter's discretion. Daily Prize Claim Details	All Daily Prize winners must claim their Daily Prize by providing bank details within two (2) weeks of being notified that they are a winner. Terms and Conditions

1. These Terms and Conditions must be read together with the Schedule for this Promotion. The Schedule prevails to the extent of any inconsistency with these Terms and Conditions. Any capitalised terms used in these Terms and Conditions have the meaning given in the Schedule, unless stated otherwise.
2. By participating in this Promotion, you accept these Terms and Conditions.

Eligibility

3. You can only enter this Promotion if you meet the eligibility requirements set out in the Schedule.
4. Directors, management, employees, officers and contractors (and their immediate families) of the Promoter, of the Participating Stores or of the agencies or organisations associated with this Promotion are ineligible to enter. "Immediate families" means spouse, parent, natural or adopted child, and sibling (whether natural or adopted by a parent), whether or not they live in the same household as the director, manager, employee, officer or contractor.
5. By entering this Promotion, if requested you agree to declare to the Promoter all past, current or potential conflicts of interest (if any) or any serious social misconduct or behavior that in a normal person's opinion may compromise the integrity or diminish the good name and reputation of the Promoter or its products and brands, is contrary to law or otherwise inappropriate.

Entry

6. The Promotion will be conducted during the Promotion Period.
7. All entries must be received by the Promoter during the Promotion Period. Entries are deemed to have been received at the time of receipt into the Promoter's database and not at the time of transmission or deposit by the entrant. Records of the Promoter and its agencies are final and conclusive as to the time of receipt.
8. You can only submit your entry in accordance with the "How to Enter" section of the Schedule. The Promoter will not accept entries in any other form. Once submitted, you cannot change, alter or delete your entry.
9. Automated entries and computer generated entries will not be accepted. Entrants who enter using multiple phone numbers, email addresses or aliases will be disqualified.
10. Incomplete and ineligible entries will be deemed invalid. Entries will also be deemed invalid if they breach these Terms and Conditions as determined by the Promoter in its sole discretion or any other instructions or guidelines notified by the Promoter during the entry process for the Promotion.
11. You are responsible for all costs associated with entering this Promotion, including but not limited to Internet and SMS costs.

Entry Content

12. You are required to take full responsibility for the content of your entry and for ensuring that your entry complies with these Terms and Conditions and any other instructions provided by the Promoter.  - h. feature any third party products, third party trade marks, names, logos or branding.
15. The Promoter may, in its absolute discretion, edit, modify, delete, remove or take-down any part of an entry at any time.
16. By entering this Promotion, you agree to assign all rights in your entry to the Promoter and you consent to the Promoter (or the agencies/companies associated with the Promoter) using the entry in any manner the Promoter wishes (including modifying, adapting or publishing the entry, whether in original or modified form, in whole or in part or not at all), in marketing, advertising and promotional materials, on the Promoter's websites and social media platforms or in any other manner as determined by the Promoter, without payment to you (of royalties, compensation or otherwise) on a perpetual, world-wide and irrevocable basis.

22. By entering this Promotion, each entrant consents to this and requests that his or her full address not be published.

Prizes

23. The prize(s) are as specified in the Schedule. The prize(s) are subject to any additional terms and conditions as specified in the Schedule.
24. Prizes will be delivered to the address provided by the winner at the time of entry or completing the verification process (whichever is most recent).
25. Once dispatched and awarded to a winner, the Promoter is not liable for any prize that has been lost, stolen, damaged, defaced or tampered with in any way.
26. If a prize is or includes gift cards/vouchers, the gift cards/vouchers are subject to any terms and conditions imposed by the gift card/voucher provider, including period of validity and treatment of unused balances.

General

29.
